(1) The shares vesting were awarded as restricted performance shares in February 2013. If it is not met, then no shares shall vest and the award shall be forfeited." The performance criteria and all requirements for vesting have been met and thus the shares fully vested on December 31, 2015, at the conclusion of the performance period.
