The new grant is for 1,095 shares of common stock represented by time-based restricted stock units. The restrictions will lapse on 361 units on each of 2/17/16 and 2/17/17 and on 373 units on 2/20/18, subject to continued employment by the Reporting Person on the vesting dates.

The new grant is for 4,384 shares of common stock represented by performance-based restricted stock units, which may be adjusted up or down at the time the performance restriction lapses. The restriction may lapse with respect to 33% of such shares on each of 2/17/16 and 2/17/17 and with respect to 34% of such shares on 2/20/18 contingent on meeting an EBT metric for 2015 and subject to continued employment by the Reporting Person on the vesting dates.

(3) Based on the Company's EBT performance in 2014, 135.5% of the original award of 4,270 performance-based restricted stock units granted 2/18/14 were earned, resulting in an additional 1,516 units, for a total of 5,786 units. The restrictions will lapse with respect to 1,909 units on 2/18/16 and with respect to 1,968 units on 2/21/17, subject to continued employment by the Reporting Person on the

remaining vesting dates.
