Of the shares of common stock being offered, 1,440,402 shares are covered by the Company's Registration Statement on Form S-3 (Registration No. 333-102244), 2,048,945 shares are covered by the Company's Registration Statement on Form S-3 (Registration No. 333-76432) and 70,653 shares are covered by the Company's Registration Statement on Form S-3 (Registration No. 333-110181). Microvision expects that delivery of the shares of common stock being offered will be made to investors on or about November 3, 2003.
