This Amendment No. 3 hereby amends the Statement on Schedule 13D initially filed on April 30, 2007 and amended on November 28, 2007 and December 6, 2007 (as amended, the Schedule 13D) by SCSF Equities, LLC, a Delaware limited liability company (SCSF Equities), Sun Capital Securities Offshore Fund, Ltd., a Cayman Islands corporation (Sun Offshore Fund), Sun Capital Securities Fund, LP, a Delaware limited partnership (Sun Securities Fund), Sun Capital Securities Advisors, LP, a Delaware limited partnership (Sun Advisors), Sun Capital Securities, LLC, a Delaware limited liability company (Sun Capital Securities), Marc J. Leder (Leder) and Rodger R. Krouse (Krouse) (collectively, the Reporting Persons) with respect to the Common Stock, par value \$0.01 per share (the Common Stock) of Georgia Gulf Corporation, a Delaware corporation (the Issuer) as follows:

Items 5 and 7 of the Schedule 13D are hereby amended to the extent hereinafter expressly set forth. All capitalized terms used and not expressly defined herein have the respective meanings ascribed to such terms in the Schedule 13D.

Item 5. Interest in Securities of the Issuer

Item 5 of the Schedule 13D is hereby amended to add the following:

- (a)-(b) On January 3, 2008, the Reporting Persons purchased shares of Common Stock increasing the total number of shares beneficially owned by the Reporting Persons on such date to 4,102,041 or approximately 11.9% of the Issuer's outstanding Common Stock.
- (c) Except for the transactions described herein or in the Schedule 13D, there have been no other transactions in the securities of the Issuer effected by the Reporting Persons during the past 60 days. On December 6, 2007, the Reporting Persons purchased 6,100 shares of Common Stock at an average purchase price per share of \$7.19. On December 13, 2007, the Reporting Persons purchased 93,400 shares of Common Stock at an average purchase price per share of \$7.62. On December 14, 2007, the Reporting Persons purchased 85,000 shares of Common Stock at an average purchase price per share of \$6.77. On December 17, 2007, the Reporting Persons purchased 50,000 shares of Common Stock at an average purchase price per share of \$6.58. On December 31, 2007, the Reporting Persons purchased 50,000 shares of Common Stock at an average purchase price per share of \$6.60. On January 2, 2008, the Reporting Persons purchased 1,300 shares of Common Stock at an average purchase price per share of \$6.39. On January 3, 2008, the Reporting Persons purchased 60,000 shares of Common Stock at an average purchase price per share of \$5.67 per share. The transactions were effected by SCSF Equities and were open market purchases on the New York Stock Exchange.
