(2) by Mr. Ghasemi at target achievement. As a result, the balance of securities beneficially owned following the transaction reported herein has been reduced by 40,608 shares, which represents the portion of the awards (and related dividend equivalents) previously reported at target in which Mr. Ghasemi is no longer eligible to vest. The ultimate number of shares of common stock to be issued to Mr. Ghasemi in respect of these awards will depend on the achievement of the performance criteria set forth in such awards.
