- (1) Reporting person deferred a portion of his 2010 performance bonus pursuant to the Long Term Incentive Plan - bonus deferral totalled 2042.628 and company match totalled 510.657 The company match vests ratably at 33%, 33% and 34% per year over a 3 year period. Special common shares vested as of 12/31/10 were 2607.2777. This bonus was approved on March 4, 2011, and we calculated the deferral using a March 4 stock price. Cash bonuses will be paid on March 11, 2011.
