On 01/15/2005, Palomar exchanged 10 million shares of Series A preferred stock for 100 million shares of Blackhawk's common stock.

(1) The 10 million shares of Series A preferred were convertible under their terms into 125,000 shares of post-split common stock. The additional 99,875,000 shares had a fair market value of \$.04 per share resulting in additional compensation of \$3,995,000.
