(1) Includes 87,931 shares acquired through the Cleco Corporation Dividend Reinvestment Plan on November 19, 2009.

The shares of phantom stock relate to shares of restricted stock granted under the Cleco Corporation Long-Term Incentive Compensation Plan. No separate value was exchanged for these shares. Except as expressly provided in the grant letter relating to these shares of restricted stock, such shares cannot be sold, assigned, transferred, pledged, hypothecated or otherwise disposed of by the reporting person prior to January 29, 2016. The reporting person has elected to defer receipt of these shares of restricted stock under the Cleco Corporation Deferred Compensation Plan (the "Plan"). Each share of phantom stock is the economic equivalent of one share of Cleco Corporation common stock. Shares of phantom stock may be transferred by the reporting person into an alternative investment account in the Plan at any time pursuant to the terms and provisions of the Plan.

(3) Includes 6,412 shares of phantom stock (not subject to restrictions) related to dividend reinvestment on shares of phantom stock pursuant to the terms and provisions of the Plan. Includes (a) 1,200 shares of phantom stock subject to restrictions that lapse on July 23, 2010; (b) 2,339 shares of phantom stock subject to restrictions that lapse on January 28, 2011; (c) 1,064 shares of phantom stock subject to restrictions that lapse on July 22, 2011; (d) 2,228 shares of phantom stock subject to restrictions that lapse on January 27, 2012; (e) 1,846 shares of phantom stock subject to restrictions that lapse on January 26, 2013; (f) 2,140 shares of phantom stock subject to restrictions that lapse on January 25, 2014; (g) 2,544 shares of phantom stock subject to restrictions that lapse on January 30, 2015; and (h) 2,149 shares of phantom stock subject to restrictions that lapse on January 29, 2016.
