or (c) the closing price of the Issuer's common stock on the OTCBB or the principal exchange on which the common stock is listed, as

(3) applicable, on the trading day preceding the date such Note is converted, in each case as adjusted for stock splits, dividends or combinations, recapitalizations or similar events.
