### (3) EXPLANATION OF ANTICIPATED CHANGE

In an effort to better align our organizational and cost structures with our future growth opportunities, in August 2005 our Board of Directors adopted a restructuring plan for our company that we expect will be completed in December 2005. The plan includes restructuring our global operations by eliminating redundancies in our Hong Kong operation, closing our Mexican facilities, converting our Guatemala facility from a manufacturing site to a distributor, and closing our North Carolina manufacturing facility. We expect to record a charge in connection with our restructuring plan of approximately \$5 million to \$7 million for the third quarter ended September 30, 2005.
