On March 6, 2008, the Reporting Person purchased 4,000 shares of common stock of iStar Financial Inc. at an average price of \$13.30 per share. The Reporting Person holds beneficial ownership of these shares indirectly as trustee of a family trust. Following this (1) transaction, the Reporting Person beneficially owns a total of 34,000 shares of iStar common stock, consisting of 20,450 shares owned indirectly as trustee of a family trust and 13,550 shares owned indirectly in a separate retirement account established by the reporting person.
