(1) Effective June 15, 2013, the Reporting Person acquired 600,000 shares of iStar common stock upon the vesting of restricted stock units (Units) pursuant to a long-term incentive award dated October 7, 2011, which award has been previously reported on Form 4. After deducting 334,920 shares for applicable tax withholdings, the Reporting Person acquired a net amount of 265,080 shares of iStar common stock.

(2) Following these transactions, the Reporting Person is the direct beneficial owner of 2,758,510 shares of iStar common stock, the indirect beneficial owner of 44,544 shares of iStar common stock owned by the Reporting Person's spouse, and the direct beneficial owner of 2,000 shares of iStar Series D preferred stock. The Reporting Person also owns a total of 1,671,534 Units, representing the right to receive an equivalent number of shares of iStar common stock (net of shares deducted for applicable taxes and other withholdings) if and when the Units vest.
