(1) The sale reported on this Form 4 was effectuated pursuant to a Rule 10b5-1 trading plan adopted by the reporting person on 02/22/10.

(2) This option became exercisable in four equal annual installments beginning on this date.

(4) Each restricted stock unit represents a contingent right to receive one share of HP common stock.

Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock. The number of derivative securities beneficially owned in column 9 includes 12.3175 dividend equivalent rights at \$53.29 per RSU credited to the reporting person's account on 04/07/10.

(6) As previously reported, on 12/10/09 the Reporting Person was granted 12,040 restricted stock units ("RSUs"), 6,020 of which will vest on 12/10/10 and 12/10/11. Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock.
