Item 7.01. Regulation FD Disclosure

On October 15, 2007, Casey's General Stores, Inc. (the "Company") reported September 2007 same-store sales results for stores open for one full year. Same store gasoline gallons sold decreased 2.3% in September 2007 compared to September 2006. The gasoline margin was above the Company's fiscal 2008 goal of 10.7 cents per gallon. The average retail price of gasoline sold during September 2007 was \$2.78 per gallon. Same-store sales of grocery and other merchandise increased 10.9% and prepared food and fountain same-store sales increased 9.8% in September 2007 compared to September 2006.
