- (1) In connection with the Issuer's initial public offering (the "IPO"), the Series A Convertible Preferred Stock, including all accrued and unpaid dividends as of the date of conversion, converted into Issuer Common Stock on a 1-for-8.0149 basis and had no expiration date.
These securities are owned directly by Birchmere Ventures III TSIB LP. BV3 LLC is the general partner of BV3 Management LP, which is the general partner of Birchmere Ventures III TSIB LP. BV3 LLC and BV3 Management LP disclaim beneficial ownership in these securities to the extent it exceeds their pecuniary interest therein.
 - (2) In connection with the Issuer's IPO, the Series B Convertible Preferred Stock, including all accrued and unpaid dividends as of the date of conversion, converted into Issuer Common Stock on a 1-for-8.0149 basis and had no expiration date.
 - (3) In connection with the Issuer's IPO, the Warrant to Purchase 19,549 shares of Series B Convertible Preferred Stock at \$0.93 per share converted into a Warrant to Purchase 2,439 shares of the Issuer's Common Stock at \$7.45 per share, as a result of the 1-for-8.0149 reverse stock split.
 - (4) In connection with the Issuer's IPO, the Convertible Promissory Note, including \$13,596.61 in accrued and unpaid interest as of the date of conversion, converted into 64,529 shares of the Issuer's Common Stock at \$8 per share.
