As explained further in footnote (2) below, Antonio R. Sanchez, III shares voting and dispositive power over the shares controlled by Sanchez Energy Partners I, LP.

(2) These shares are owned directly by Sanchez Energy Partners I, LP. Sanchez Energy Partners I, LP is controlled by its general partner, SEP Management I, LLC, which is a wholly-owned subsidiary of Sanchez Oil & Gas Corporation. Sanchez Oil & Gas Corporation is managed by A.R. Sanchez, Jr. and Antonio R. Sanchez, III. Antonio R. Sanchez, III shares voting and dispositive power over the shares controlled by Sanchez Energy Partners I, LP. Antonio R. Sanchez, III disclaims beneficial ownership of these securities except to the extent of his pecuniary interest therein, and the inclusion of these securities in this report shall not be deemed an admission of beneficial ownership of all of the reported securities for purposes of Section 16 or any other purpose.
