- (1) The shares were applied to the payment of withholding taxes arising in connection with the vesting of 7,007 shares on February 7, 2014, which vested upon the Company achieving three-year Total Stockholder Return (as compared to the Company's ISS peer group), for the three-year period ending December 31, 2013, equal to or greater than the 50th percentile in that peer group. The achievement of such Total Stockholder Return was certified on February 7, 2014.
- (2) Represents the closing price (and selling price) of Issuer's common stock on February 7, 2014.
- (3) 7,007 shares shall vest upon the Company achieving total revenue in any of the 2013, 2014, or 2015 fiscal years equal to or greater than \$12 billion; 7,007 shares shall vest upon the Company achieving three-year EBITDA margin for the three-year period ending December 31, 2013, equal to or greater than 2.5%; 19,586 shares vest on March 1, 2014; 15,461 shares vest on March 1, 2015; and 6,086 shares vest on March 1, 2016. The remainder of the shares are vested.
