Unilever NV announces that on 15 February 2008 it purchased 2,300,000 Unilever NV ordinary shares (in the form of depositary receipts thereof) at prices between euro 20.630 and euro 21.290 per share. The purchased shares will be held as treasury shares.

Unilever NV also announces that 9,123 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 130,115,840 Unilever NV ordinary shares in treasury, and has 1,584,611,860 Unilever NV ordinary shares in issue (excluding treasury shares).
