Unilever NV also announces that 58,535 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 136,734,999 Unilever NV ordinary shares in treasury, and has 1,577,992,701 Unilever NV ordinary shares in issue (excluding treasury shares).
