Accordingly, the Board of HSBC Holdings plc has declared a dividend for the quarter ending 15 March 2013. The dividend of US\$0.3875 per Series A American Depositary Share will be payable on 15 March 2013 to holders of record on 1 March 2013.

Any person who has acquired Series A American Depositary Shares but who has not lodged the transfer documentation with the depositary should do so before 12 noon on Friday, 1 March 2013 in order to receive the dividend.
