**EXPLANATORY STATEMENT**

This Post-Effective Amendment No.1 relates to the Registration Statement on Form S-8 (Commission File No. 333-62917), filed with the Securities and Exchange Commission (the SEC) on September 4, 1998 (the Prior Registration Statement) by Altera Corporation (the Registrant) relating to 1,200,000 shares of common stock of the Registrant reserved for issuance under the Altera Corporation 1996 Stock Option Plan (the 1996 Plan) and 170,000 shares of common stock of the Registrant reserved for issuance under the Altera Corporation 1998 Director Stock Option Plan (the Director Plan).

On May 10, 2005, the Registrant's stockholders approved the Altera Corporation 2005 Equity Incentive Plan (the 2005 Plan) that replaces the 1996 Plan and the Director Plan. Under the terms of the 2005 Plan, the Registrant carried forward 10,619,500 shares of its common stock that were previously authorized but remained unissued under the 1996 Plan and the Director Plan (the Unissued Shares). The Unissued Shares were registered in a Registration Statement on Form S-8 relating to the 2005 Plan and filed with the SEC on June 17, 2005 (Commission File No. 333-125904) (the New Registration Statement). The portion of the filing fee paid in connection with the Prior Registration Statement relating to the shares being deregistered hereby was carried over to the New Registration Statement.

The Registrant is filing this Post-Effective Amendment No. 1 to deregister all securities previously registered under the Prior Registration Statement that remain unissued.
