**Item 8.01 Other Events.**

Throughout this document, AT&T Inc. is referred to as AT&T. On August 31, 2007, AT&T closed its sale of U.S. \$2,000,000,000 principal amount of its 6.500% Global Notes due 2037 (the Notes ) pursuant to an Underwriting Agreement dated August 28, 2007 (the Underwriting Agreement ), by and among AT&T and Banc of America Securities LLC, Barclays Capital Inc. and Merrill Lynch, Pierce, Fenner & Smith Incorporated, as representatives of the several Underwriters named in Schedule II thereto. The Notes were issued pursuant to that certain Indenture dated November 1, 1994 between SBC Communications Inc. (now known as AT&T Inc.) and The Bank of New York, as Trustee. The Notes have been registered under the Securities Act of 1933 (the Act ) pursuant to a Registration Statement on Form S-3 (No. 333-143180) previously filed with the Securities and Exchange Commission (the Commission ) under the Act. Copies of the Underwriting Agreement and the form of Note are filed as exhibits hereto and incorporated herein by reference. AT&T is filing this Current Report on Form 8-K so as to file with the Commission certain items that are to be incorporated by reference into its Registration Statement.
