Item 1.01. Entry into a Material Definitive Agreement

On February 25, 2008, SYNNEX Corporation, a Delaware corporation (SYNNEX), announced that it had entered into a definitive agreement in which SYNNEX will acquire substantially all of the assets of New Age Electronics, Inc. Total consideration for the purchased assets is approximately \$54.25 million, which includes approximately \$22.75 million in deferred and earn out payments that are subject to certain post-closing conditions, and approximately \$75.00 million of working capital debt assumption. Completion of the transaction is subject to regulatory and other approvals, and the satisfaction of other customary closing conditions.
