The name of the issuer is Avago Technologies Limited (Avago), a public limited company incorporated under the laws of the Republic of Singapore.

Seletar is wholly-owned by Temasek Capital, which in turn is wholly-owned by Temasek Holdings; therefore each of Temasek Holdings and Temasek Capital may be deemed to beneficially own the Ordinary Shares directly owned by Seletar.

Accordingly, as of December 31, 2010, each of Temasek Holdings and Temasek Capital may be deemed to beneficially own 12,440,675 Ordinary Shares.

On January 21, 2011, Seletar sold 2,675,121 Ordinary Shares of Avago as a selling shareholder, and may sell additional shares in any over-allotment option, in the registered secondary offering of Ordinary Shares of Avago reported in Avago's prospectus supplement (File No. 333-168621) (as amended) filed with the Securities and Exchange Commission on January 18, 2011.

(b) Percent of class: As of December 31, 2010, the percentage of the class represented by the amount in Item 4(a) is 5.1%, which is based on a total of 241,589,163 Ordinary Shares outstanding on December 10, 2010, as set forth and described in the Issuer's Form 10-K filed with the Securities and Exchange Commission on December 15, 2010.
