On March 6, 2012, Lincoln Electric Holdings, Inc. (the Company) issued a press release announcing that it had acquired all of the outstanding stock of Weartech International, Inc., a California corporation, along with its wholly-owned subsidiary, Weartech International Limited, a company organized under the laws of England and Wales (collectively, Weartech). Weartech, a producer of cobalt-based hard facing and wear-resistant welding consumables, is located in Anaheim, California and Port Talbot, Wales.
