**Amendment No. 14 to Schedule 13D**

The Reporting Persons (as defined below) hereby amend and supplement the statement on Schedule 13D filed with the Securities and Exchange Commission (the Commission ) on April 9, 2007, as amended by Amendment No. 1 thereto filed on May 14, 2007, Amendment No. 2 thereto filed on June 4, 2007, Amendment No. 3 thereto filed on June 5, 2007, Amendment No. 4 thereto filed on June 20, 2007, as amended and restated by Amendment No. 5 thereto filed on June 20, 2007, as amended by Amendment No. 6 thereto filed on August 22, 2007, as amended by Amendment No. 7 thereto filed on May 23, 2008, as amended by Amendment No. 8 thereto filed on June 2, 2008, as amended by Amendment No. 9 thereto filed on July 3, 2008, as amended by Amendment No. 10 thereto filed on June 23, 2010, as amended by Amendment No. 11 thereto filed on October 14, 2010, and as amended by Amendment No. 12 thereto filed on November 8, 2011, as amended by Amendment No. 13 thereto filed on January 5, 2012 with respect to, among other things, the Reporting Persons' beneficial ownership of series B shares ( Series B Shares ) (including Series B Shares underlying the American Depositary Receipts ( ADSs )) of Grupo Aeroportuario del Sureste, S.A.B. de C.V., a limited liability publicly traded corporation with variable capital stock (*sociedad anónima bursátil de capital variable*) (the Company ), organized under the laws of the United Mexican States ( Mexico ). According to its public filings with the Commission, the Company, through its subsidiaries, operates airports in the southeastern region of Mexico. Defined terms used but not defined herein shall have the respective meanings given to such terms in Amendment No. 5 or Amendment No. 6.

Item 4. Purpose of Transaction

Item 4 is hereby amended by adding at the end of the Item the following paragraph:

Corporativo Galajafe, S.A. de C.V. ( Corporativo Galajafe ), an entity owned and controlled entirely by Grupo ADO, S.A. de C.V. ( ADO ), owns 4,760,125 Series D shares of ITA, representing 49% of the total outstanding shares of ITA. Corporativo Galajafe intends to nominate a member to the Board of Directors of the Company that will be appointed by ITA, as the sole holder of the Company's Series BB shares, at the next annual meeting of shareholders and replace an existing member who was also appointed by ITA. Mr. Chico will cooperate and assist in the nomination and appointment of such additional director through his 51% stake in ITA.
