As of December 31, 2012 (i) AVLP was the record holder of 11,514,953 shares of Common Stock (the AVLP Shares); (ii) Artiman Ventures Side Fund, L.P. (AVSF) was the record holder of 74,405 shares of Common Stock (the AVSF Shares); (iii) Artiman Ventures Side Fund II, L.P. (AVSFII) was the record holder of 150,533 shares of Common Stock (the AVSFII Shares and, together with the AVLP Shares and the AVSF Shares, the Artiman Shares); (iv) Artiman Management, LLC (Artiman Management) was the record holder of 20,000 shares of Common Stock (the Management Shares), and (v) Amit Shah was the record holder of options to purchase 5,000 shares exercisable within 60 days of December 31, 2012.

Artiman, L.L.C., the general partner of AVLP, AVSF and AVSFII, may be deemed to beneficially own the Artiman Shares. Amit Shah, as (i) a Managing Member of Artiman, L.L.C., the general partner of AVLP, AVSF and AVSFII, and (ii) the Managing Member of Artiman Management, may be deemed to beneficially own the Artiman Shares and the Management Shares, respectively. Such entity and person disclaim beneficial ownership of the Artiman Shares and the Management Shares except to the extent of any pecuniary interest therein.

The Reporting Persons may be deemed to constitute a group for purposes of Section 13(d)(3) of the Act. Pursuant to Rule 13d-4 of the Act, the Reporting Persons expressly declare that the filing of this Statement shall not be construed as an admission that any such person is, for the purposes of Section 13(d) and/or Section 13(g) of the Act or otherwise, the beneficial owner of any securities covered by this Statement held by any other person.
