(d) On July 9, 2013, Rochelle B. Lazarus was appointed to the board of directors of Blackstone Group Management L.L.C., the general partner (the General Partner) of The Blackstone Group L.P. (the Partnership), and its Audit Committee.

Ms. Lazarus will receive an annual cash retainer of \$150,000. In addition, Ms. Lazarus received upon her appointment a grant of deferred restricted common units with a value of \$150,000 under the Partnership's 2007 Equity Incentive Plan. These deferred restricted common units will vest, and the underlying common units will be delivered, on the first anniversary of the date of grant, subject to Ms. Lazarus' continued service on the board of directors of the General Partner.
