On October 30, 2017, Fulton Financial Corporation ( Fulton ) announced that the Office of the Comptroller of the Currency (the OCC ) has terminated the Consent Orders issued by the OCC on July 14, 2014 to three of Fulton 's bank subsidiaries, Fulton Bank, N.A., FNB Bank, N.A. and Swineford National Bank, relating to deficiencies in the Bank Secrecy Act and anti-money laundering compliance programs at those banks.
