The distribution will be payable on March 15, 2007 to unitholders of record on February 28, 2007. The ex-distribution date is February 26, 2007. A cash payment of \$0.19 per unit will also be made to holders of Class B limited partnership units of Precision Drilling Limited Partnership using the same record date and payment date.

As previously announced, the Distribution Reinvestment Plan has been suspended until further notice.
