The option remains exercisable after Ms. Hawthorne ceases to be Interim Chief Executive Officer only to the extent that she was entitled to exercise the option on the date of such cessation, provided she continues to serve as an employee or director of, or consultant or advisor to, the Company (an "Eligible Optionee"). If Ms. Hawthorne ceases to be an Eligible Optionee, the right to exercise this option shall terminate three months after such cessation (with certain exceptions).
