The amount of any cash distribution from the reporting person's phantom share account will be made at a value equal to the average of the high and low sales prices of a share of DTE common stock as listed in The Wall Street Journal for the New York Stock Exchange Composite tape on a specified date. Includes phantom stock acquired through the reinvestment feature of this plan.
- (5) The grant of the stock option has previously been reported.
- (6) The phantom shares are immediately vested, but subject to a 3 year deferral. The director had a one time option to defer payment upon termination from the board. Includes phantom stock acquired through the reinvestment feature of this plan.
