The share and option exercise price information presented above gives effect to a 7.9485 to 1 stock split for all common shares, which was effected immediately prior to the closing of the Issuer's initial public offering. The final ratio for this stock split was adjusted from (1) that reported on the reporting person's original Form 3. This Form 3/A is not being filed to report a new transaction, but rather is being filed solely to report an administrative error in the calculation of the stock split ratio and a resulting revision in the amount of securities beneficially owned by the reporting person.

(2) The options are fully vested and exercisable.

(3) The options vest in four equal, annual installments beginning on March 6, 2007.

(4) Due to an administrative error, the expiration date of the options was incorrectly reported on the reporting person's original Form 3.
