(GR1) As previously reported, on February 25, 2010, the reporting person received a grant of 36,830 performance restricted units that were subject to the issuer's attainment of a specified one-year performance metric for the year then-ending December 31, 2010. The performance metric was met; therefore, these restricted units vest ratably on each of the first, second and third anniversaries of the date of grant. The first anniversary of this grant occurred on February 25, 2011, resulting in the vesting and settlement of 12,276 shares of common stock. The second anniversary of this grant occurred on February 25, 2012, resulting in the vesting and settlement of 12,277 shares of common stock, as shown in Table I. The remaining 12,277 performance restricted units, which are scheduled to vest on February 25, 2013, are shown in Table II. Restricted units are settled in shares of the issuer's common stock upon vesting.
