(1) This entry represents the number of shares of ViaSat, Inc. common stock withheld by the Issuer to satisfy the tax withholding obligation of the Reporting Person. (2) The original restricted stock unit grant was for 7,083 restricted stock units on 11/10/2011. (3) Until vested, the restricted stock unit shall be subject to forfeiture in the event of termination of employment with the issuer.
