(2) This share is held by Talen Energy Holdings, Inc., the sole shareholder of the Issuer. Talen Energy Holdings, Inc. is a wholly-owned subsidiary of PPL Corporation. The reported disposition represents 100% of the equity holdings of the Reporting Persons in the Issuer on the record date.
