On December 17, 2012, Ashford Hospitality Trust, Inc. (the "Company") issued a press release announcing that its Board of Directors:

- a) declared a common stock dividend for the fourth quarter ending December 31, 2012, of \$0.11 per diluted share, payable January 15, 2013, for shareholders of record on December 31, 2012.
- b) declared a dividend for the the fourth quarter ending December 31, 2012, of \$0.5344 per diluted share, for the Company's 8.55% Series A Cumulative Preferred Stock. This dividend is payable January 15, 2013, for shareholders of record on December 31, 2012.
- c) declared a dividend for the the fourth quarter ending December 31, 2012, of \$0.5281 per diluted share, for the Company's 8.45% Series D Cumulative Preferred Stock. This dividend is payable January 15, 2013, for shareholders of record on December 31, 2012.
- d) declared a dividend for the fourth quarter ending December 31, 2012, of \$0.5625 per diluted share, for the Company's 9.00% Series E Cumulative Preferred Stock. This dividend is payable January 15, 2013, for shareholders of record on December 31, 2012.
- e) approved the Company's dividend policy for 2013. The Company expects to pay a quarterly cash dividend of \$0.12 per share in 2013, but will continue to review its dividend policy on a quarter-to-quarter basis.
