- (1) On July 27, 2000, the reporting person was granted an option to purchase 67,500 shares of common stock. The option vests in five annual installments beginning on July 27, 2001.
- (2) On January 7, 2002, the reporting person was granted an option to purchase 45,000 shares of common stock. The option vests equally in three annual installments beginning on January 7, 2003.
- (3) On January 6, 2004, the reporting person was granted an option to purchase 45,000 shares of common stock. The option vests equally in three annual installments beginning on January 6, 2005.
- (4) On August 27, 2003, February 12, 2001 and December 12, 2001, the Company effected 3-for-2 stock splits. The above share amounts and prices reflect the effect of the stock splits.
- (5) On February 7, 2006, the reporting person was granted an option to purchase 10,000 shares of common stock. The option vests equally in three installments beginning on February 7, 2007.
