**MEXICO CITY, MEXICO, April 17, 2009.** **AMÉRICA MÓVIL, S.A.B. DE C.V. ( AMX )** (BMV: AMX; NYSE: AMX; Nasdaq: AMOV; LATIBEX: XAMXL) announced that today it issued a bond in the Chilean market for UF 4,000,000 (USD 145 million equivalent) with a yield of 3.31% and a maturity of 5 years. The issuance had very good acceptance amongst local investors. América Móvil is the first foreign issuer to place a bond in the local Chilean market.
