- On December 7, 2006, BG declared a cash dividend payable to all holders of record of BG common stock on February 14, 2007. Pursuant to the terms of a performance based restricted stock unit award granted to the reporting person in 2004, cash dividends are accrued and paid in the form of BG common stock based on the target number of restricted stock units upon the settlement of the award.
