ITEM 2.01 COMPLETION OF ACQUISITION OR DISPOSITION OF ASSETS.

On August 22, 2014, Blue Earth, Inc. (the Company), through its subsidiary, Brooks Heat & Power Ltd., entered into a power agreement and land lease to design, build, finance, own and operate an approximately \$29 million co-generation power plant to be located at JBS Food Canada, Inc.'s facility in Brooks, Alberta, Canada and JBS agreed to purchase thermal and electrical energy from this Combined Heat & Power (CHP) facility.
