The symbol change is being affected in connection with the Company's July 27, 2012 name change from Blast Energy Services, Inc. to PEDEVCO Corp., which name change was undertaken as part of the requirements of the January 13, 2012, Agreement and Plan of Reorganization (the "Merger Agreement"), by and between the Company, Blast Acquisition Corp., a wholly-owned Nevada subsidiary of the Company, and Pacific Energy Development Corp., a privately-held Nevada corporation, which Merger Agreement and transactions contemplated therein were also consummated on July 27, 2012.
