(1) On February 28, 2017, the reporting person was granted 13,388 performance-based restricted stock units ("RSUs") pursuant to the Issuer's 2015 Omnibus Incentive Compensation Plan (the "Plan"). The performance-based RSUs vest in three equal annual installments based on the Issuer's satisfaction of certain performance criteria for each of the fiscal years 2017, 2018 and 2019. The performance criteria for 2018 were met, resulting in the vesting of 4,463 performance-based RSUs.

- (2) RSUs convert into common stock on a one-for-one basis.

On February 20, 2018, the reporting person was granted 4,770 performance-based RSUs pursuant to the Plan. The performance-based

- (3) RSUs vest in three equal annual installments based on the Issuer's satisfaction of certain performance criteria for each of the fiscal years 2018, 2019 and 2020. The performance criteria for 2018 were met, resulting in the vesting of 1,590 performance-based RSUs.
- (4) Represents the number of shares withheld for the payment of tax liabilities in connection with the vesting of 6,053 performance-based RSUs.

On September 20, 2013, the reporting person was granted an option to purchase 40,875 shares of common stock. The option vests in five

- (5) equal annual installments based on the Issuer's satisfaction of certain performance criteria for each of the fiscal years 2014, 2015, 2016, 2017, and 2018. The performance criteria for 2018 were met, resulting in the vesting of 8,175 shares.
