On April 18, 2018, PTC Inc. announced that it intends to repurchase \$100 Million of its common stock under an accelerated repurchase agreement it expects to enter into on April 20, 2018 as part of its previously announced stock repurchase program. PTC may be unable to enter into the repurchase agreement when or as planned if intervening events occur.
