This calculation requires the input of certain assumptions, including the risk-free interest rate and the expected Company stock dividends. The formula for determining the number of RSUs granted is:  $\text{number of RSUs} = \% \text{ of base pay} / \text{RSU fair value}$ . This Form 4 will be amended to report the number of RSUs granted when the number has been calculated.
