Item 4. Ownership.

(a) Amount Beneficially Owned:

As of the date of this filing, (i) Inversora Carso, directly or indirectly, owns 8,247,175 Class A Common Shares and (ii) GFI, directly or indirectly, owns 7,950,000 Class A Common Shares.

Of the aforementioned shares, (i) Inversora Carso has pledged 8,247,175 Class A Common Shares to the 2017 Mandatory Exchangeable Trust (the "Trust") pursuant to forward agreements dated December 15, 2017 among the Trust and each of Inversora Carso and CEC and (ii) GFI has pledged 7,950,000 Class A Common Shares (together with the pledged shares by Inversora Carso, the "Pledged Shares") to the Trust pursuant to a forward agreement dated December 15, 2017 among the Trust and Banco Inbursa S.A., Institución de Banca Múltiple, Grupo Financiero Inbursa ("Inbursa"). Inversora Carso and Inbursa retain voting rights to the Pledged Shares and now share dispositive power with U.S. Bank National Association ("U.S. Bank") as collateral agreements dated December 15, 2017 among U.S. Bank, the Trust and each of Inversora, CEC and Inbursa.

Because the members of the Slim Family are beneficiaries of a Mexican trust which in turn owns all of the outstanding voting securities of Inversora Carso and a majority of the outstanding voting equity securities of GFI, the Slim Family may be deemed to beneficially own indirectly the Class A Common Shares beneficially owned, directly or indirectly, by Inversora Carso and GFI.

(b) Percent of Class:

The Class A Common Shares beneficially owned by the Slim Family constitute approximately 9.87% of the 164,146,697 issued and outstanding Class A Common Shares, as reported in the Form 10-Q filed by the Issuer with the Securities and Exchange Commission on November 2, 2018.

The Class A Common Shares beneficially owned by Inversora Carso constitute approximately

5.02% of the 164,146,697 issued and outstanding Class A Common Shares, as reported in the Form 10-Q filed by the Issuer with the Securities and Exchange Commission on November 2, 2018.
