Capital Group is the investment advisor to Anchorage Offshore and PCI Fund. Management is the sole managing member of Capital Group. Mr. Davis is the President of Capital Group and a managing member of Management, and Mr. Ulrich is the Chief Executive Officer of Capital Group and the other managing member of Management.

The total amount of Shares includes: (A) approximately 7,343,465 Shares obtainable upon conversion of \$114,558,000 of the Notes held for the account of Anchorage Offshore; and (B) approximately 156,538 Shares obtainable upon conversion of \$2,442,000 of the Notes held for the account of PCI Fund.

As of December 31, 2014, each of the Reporting Persons may be deemed the beneficial owner of approximately 7.7% of Shares outstanding. (There were 90,055,809 Shares outstanding as of October 16, 2014, according to the Issuer's Form 10-Q, filed October 23, 2014. Each of the Reporting Persons may be deemed the beneficial owner of approximately 7,500,003 Shares obtainable upon conversion of \$117,000,000 of the Notes. Pursuant to Rule 13d-3(d)(1)(i)(D), such Shares have been added to the Issuer's number of Shares outstanding, for a total of approximately 97,555,812 Shares outstanding.)
