The Restricted Stock Units were granted under the 2006 Stock Incentive Plan of Honeywell International Inc. and its Affiliates and vest as follows: 33% on October 6, 2012, 33% on October 6, 2014 and 34% on October 6, 2016, subject to a maximum up or down adjustment of 20% based on Honeywell's total shareowner return (TSR) relative to its compensation peer group of companies over both a 1-year and 30-month period ending December 31, 2012. The October 6, 2012 tranche will vest based on the target award with any adjustment from relative TSR performance applied equally to the October 6, 2014 and October 6, 2016 tranches.
