## Item 1.01 - Entry into Material Definitive Agreements

On October 25, 2007, Reunion Industries, Inc. ("Reunion") entered into an Asset Purchase Agreement to sell the business and substantially all of the assets and operating liabilities of its CP Industries division to CPI Industries, Inc. ("Buyer") for consideration, subject to adjustment, of \$56 million to be paid at closing and \$2 million in deferred payments. The sale is scheduled to close on December 15, 2007, subject to certain conditions precedent, including satisfactory completion of the Buyer's due diligence and its obtaining senior debt financing for the transaction.

Reunion's CP Industries division manufactures and sells large seamless pressure vessels for the containment and transportation of pressurized gasses. The Buyer is an affiliate of H.I.G. Capital, LLC.
