On June 24, 2014, the Company pre-announced estimated second quarter pre-tax catastrophe losses, net of reinsurance, of approximately \$20.0 million to \$23.0 million due to spring storms, which the Company expects to have an earnings per share impact of \$0.51 to \$0.59, after tax.
